You may register up to 3 dogs. Cash or Check (written to City of Canandaigua) Only.

Registrations are for the calendar year purchased. **Permits may be purchased any time but are not prorated and expire 12/31/2024.** A photo ID, a copy of your dog license, and rabies documentation are required. Registration fees are non-refundable and non-transferable. Couples may purchase one extra key card for \$10. Replacement fees for lost key cards or collar tags are \$10 (\$20 second replacement, \$30 third replacement, etc.). Re-register in person at the end of the calendar year to receive your new key card and correct collar tag(s).

Canandaigua Canine Campus (CCC) Dog Park is a safe and healthy off-leash play space for responsible pet owners and their socialized, trained and friendly dogs. **Please DO NOT register your dog if he/she is under 6 months of age or if he/she is aggressive and/or has threatened, harmed, or bitten another dog and/or person.**

ACKNOWLEDGEMENT OF RISK, RELEASE OF LIABILITY AND TERMS OF AGREEMENT

CANANDAIGUA CANINE CAMPUS DOG PARK, CITY OF CANANDAIGUA

I hereby apply to use the Canandaigua Canine Campus (CCC) Dog Park, which is operated by The City of Canandaigua, with my dog(s).

I understand and acknowledge that:

- The CCC Dog Park is not supervised.
- Being physically present inside the CCC Dog Park with my dog(s), whether leashed or unleashed, necessarily involves risks of injury to other people and their dog(s) from my dog(s).
- Dogs may act or react unpredictably.
- Dogs may be infected with diseases and/or parasites which might infect me and/or my dogs(s).
- Both dog collar tag and key card need to be with me at the CCC Dog Park.
- Dog Park use requires registration and I will not let an unregistered user into the CCC Dog Park
- **My membership may be revoked for dog park rule violations.**

I hereby expressly assume all of these risks.

I hereby agree to defend and indemnify The City of Canandaigua and its agents, servants and employees from all claims and lawsuits that may be brought against The City of Canandaigua and/or its agents, servants and employees as a result of my acts or omissions and/or the actions of my dog(s) in the CCC Dog Park.

I hereby release the City of Canandaigua and its agents, servants and employees from all injuries that I and/or my dog(s) sustain in the CCC Dog Park as a result of the acts or omissions of their dog owners/handlers and/or the actions of their dog(s) in the CCC Dog Park.

I have read, understand and agree to the terms and conditions of this Acknowledgement of Risk, Release of Liability, and Terms of Agreement document and *Membership: Code of Behavior* handout.
